ORDER

Upon consideration of the United States' proposed briefing schedule in this action, IT IS
HEREBY ORDERED THAT:

- 1) The United States shall file a motion to dismiss the underlying action, and file a motion to dismiss the cross-counterclaim on or before October 10, 2016;

2) Plaintiff/Counterclaim Defendant Mark Crumpacker shall file an opposition to the United States' motion to dismiss the complaint on or before October 28, 2016;

3) Counterclaim Defendants Michael B. Ellis and Robert A. McNeil shall file an opposition, if any, to the United States' motion to dismiss the cross-counterclaim on or before October 28, 2016;

4) The United States shall file a reply brief in support of its motion to dismiss the complaint, and a reply brief in support of its motion to dismiss the cross-counterclaim on or before November 11, 2016;

5) The United States shall file a dispositive motion with respect to its counterclaim on or before December 2, 2016;

6) Counterclaim Defendants Mark Crumpacker, Michael B. Ellis, and Robert McNeil shall file an opposition, if any, to the United States' dispositive motion with respect to its counterclaim on or before January 6, 2017;

7) The United States shall file a reply in support of its dispositive motion with respect to its counterclaim on or before January 20, 2016.
